

2019 Fair: Poultry Update

Due to the current outbreak of Virulent Newcastle Disease in California, **the breeding and market poultry shows have been cancelled** for the 2019 Ventura County fair, July 31-August 11, 2019.

This cancellation is a recommendation from State Veterinarian & Director for Animal Health and Food Safety Services, Annette M. Jones, D.V.M. The poultry shows will return next year.

Although live birds cannot be on grounds, poultry and turkey showmanship classes will continue as well as additional exhibit opportunities in the small livestock area for the youth to educate the public on poultry.

Complete details will be printed in the Small Livestock Entry Guide which will be available in April.
